. Tandem # 4 - Rider # VENGE BALBOA Christian – ESP - (UCI ID 100 085 354 75) – pilot : MARTIN INFANTE Noël - ESP – (UCI ID 100 071 752 53), is fined CHF 250 ,- and penalised by a reduction of 15 points in the UCI rankings for disposing of waste or other objects outside of litter zones, or not returned to team or organisation staff, not collected by team staff. (Art. 12.2.007/8.3).

. Tandem # 2 – Rider # TAYLOR Lowell – CAN – (UCI ID 100 604 715 01) – pilot : VEAL Ed – CAN – (UCI ID 100 093 187 51) received a warning for dangerous riding.

ROAD RACE (WOMEN'S C4-5) / COURSE SUR ROUTE (WOMEN'S C4-5)

Rider # 162 – VAN DE POL Martin (MC5) - NED (UCI ID 100 111 121 40) for failing to respect the instructions of the organiser or commissaires (warming up on the circuit during a competition). Fine of CHF 50. Art. 12.2.007/8.1.
