Tandem #6 – SANSO RIERA, Joan – ESP (UCI ID 101 243 546 87) / FONT BERTOLI, Joan – ESP – (UCI ID 100 153 498 28) is fined CHF 250 ,- and penalised by a reduction of 15 points in the UCI rankings for disposing of waste or other objects outside of litter zones, or not returned to team or organisation staff, not collected by team staff.
